SELECTMEN'S REPORT

As we reflect on another year dealing with budget constraints, we want to commend each department in their efforts to holding costs in line. We know there have been circumstances when creative thought was used in funding various projects. Team work plays a very important role. Some of the projects that have been accomplished in our town are:

- ❖ The Marsh Stream culvert replacement on the Kennebec Road - Larger culverts were put in, the road bed was raised, and bolder borders were added. This was completed by Gerald & David Wood under the watchful eye of Neal Sprague, Road Commissioner. FEMA funds were used at a very considerable savings to our town. A job well done!!!!
- ❖ Bush cutting, chipping , as well as ditching, has been completed on the following side roads: Smalls Point, Pettegrow Point, East Side, and Clarks Point Road. This was done by our own town crew under the supervision of Neal Sprague.

The Marion Transfer Station closed their landfill on January 1st of this year. The Board of Directors contracted with Southwest Solid Waste Commission to accept our solid waste at their facility at Lawrence Station in New Brunswick, Canada. This has been a smooth transition with minor changes.

We would like to take this opportunity to again thank the various committees for their hard work and dedication, the Downeast Correctional Facility and the minimum security inmates for the many projects they have completed this past year, and to the residents of Machiasport for their support.

In closing, we would like to acknowledge and thank Richard Stanhope for all that he does in keeping the Veterans' Memorial looking great!!! And to all others who help and volunteer in keeping our Municipal Complex looking good...thank you all!

**SUPERINTENDENT OF SCHOOLS
ANNUAL REPORT**

To: The Machiasport School Committee and the Citizens of Machiasport:

Several months ago I received the exciting news that the Town of Machiasport will receive over \$93,000.00 more in subsidy for the upcoming 2012/2013 school year as compared to our current level of school funding. The increase is primarily due to Senator Raye's bill, An Act to Restore Equity in Education Funding, that became law this year.

As a result of an increase in state subsidy for the 2012/2013 school year, the tax commitment for education will reflect no increase. Even though the Federal Jobs Fund money will not be available during the upcoming school year and several budget items increased, the additional subsidy was significant enough to offset the increases which has allowed the tax commitment to remain exactly the same as last year.

The School Committee, administration and staff are committed to provide the best possible educational experience for the students that attend the Fort O'Brien School. The Building Principal, Susan Almendinger, teachers and support staff work hard every day to meet the needs of the student body.

The School Committee continues to support annual improvements to the physical plant. This past summer a new boiler was installed and several windows have been replaced with more efficient egress windows on the second floor of the building. The School Committee is planning on continuing with building improvements in the upcoming year that include the following: 1) upgrading the fire alarm system, 2) making several bathrooms handicapped accessible, 3) paving upgrades, 4) building a dormer on the entry roof to divert water flow coming off the roof.

In closing, it has been a pleasure to work with the Machiasport School Committee. Chairperson Rose Williams, Joleen Nicely and Jeff Chick have worked hard to provide the necessary resources to ensure that the educational needs of the student body are met.

I welcome the citizens of Machiasport to stop by my office if any of you have questions about our proposed budget or any other issues that need to be discussed. Thank you for your support of the Machiasport School Department.

Fifty-six (56) attend Fort O'Brien Elementary at this time. We have a teaching principal, three full time classroom teachers, a full time special education teacher with a full time educational technician, a Title 1 Teacher, and an educational technician who serves grades 4-8. We have a part time secretary and 3 special subject teachers who come on Wednesdays that include physical education, art, and music.

Our students made Average Yearly Progress again this year on the NECAP. Students in grades K-8 also took the NWEA in the fall and spring of which they did very well indicating consistent academic growth for the year.

As a staff, we have been participating in a book study using *Teach Like a Champion* by Doug Lemov. This book has been instrumental in allowing teachers and principal to examine how best to maximize instructional time invested in by teachers and students. We are in the process of choosing a new book for next year's professional research.

Fort O'Brien teachers have also been working on the new Common Core Standards at the A.O.S. #96 level. They have selected standards for English Language Arts and will move to the next phase of professional development in the fall of 2012.

We have an active parents' group, SIL. They have demonstrated a strong focus on how they support classroom learning through raising funds for guest speakers and specific education programs. SIL with the help of our cook, Paula Davis, put on a wonderful community dinner in December serving over 200 guests. They also planned our Community Day where 9 local presenters showcased the tools of their trade. The day was capped off with the arrival of the Forestry Department helicopter where students were able to talk with the pilot about how important spotting potential fires is to our county and state. With this kind of support and investment from parents, our school flourishes.

Finally, our school community continues to make the kinds of improvements that our students deserve. It is with teacher dedication, student motivation, parent participation and community support that we can be – simply, the stepping stones for students on their way to college and beyond.

2012 SHELLFISH COMMITTEE and WARDEN REPORT

Not much has changed this year for the Town of Machiasport.

The biggest concern we currently have is the continued closure of Point of Flats and Sanborn Cove due to issues with Machias. All the money and time that was spent to fix the issue at the Machias sewer plant have not stopped discharge into the river on heavy rain storms. Machiasport diggers have been denied access to the best producing sets of flats on numerous occasions this year already. Every time Machias overflows into the river, those sets of flats are shut down for at least 14 to 16 days. I urge anyone who has concerns over this continuing problem to either call the Machias Town Office at 255-6621 or the Department of Marine Resources in Lamoine at 667-3373.

On the positive side, the Bucks Harbor Creek is now open to harvest. Hopefully more areas of the Machias River will be opened as well at some point.

Machiasport Planning Board and Ordinance Committee Annual Report 2011 - 2012

Another successful year has passed for the Planning Board and a lot of accomplishments were made in the process.

During the Town's FY 2011-2012 there were 15 Building Permits considered by the Planning Board. In 2011, 7 permits were approved with one permit denied because the time for an extension had expired. As of the end of May 2012, 7 permits were approved.

The subdivision application proposed for the Long Point Subdivision was put on hold due to a court case to determine the ownership of the East Side Road from the culvert at the beach to the point. The proposed application for the subdivision has since been withdrawn and the property owner is negotiating with the Maine Coast Heritage Trust on a possible purchase of the land.

The Ordinance Committee is presently working on revisions to the Subdivision Ordinance that will be voted on at a future Town Meeting.

The Planning Board developed a Building Permit Brochure to help the townspeople with applications and one was sent to each Machiasport resident in January 2012. Additional copies of the brochure are available at the Town Office.

The Planning Board and Ordinance Committee have recently submitted three new Ordinances that were requested by the Selectmen for approval at the Town Meeting in June. They were:

- Exempting Eligible Active Duty Personnel From Vehicle Excise Tax
- Property Assessed Clean Energy (PACE) to be administered by Efficiency Maine Trust
- Animal/Dog Control Ordinance

The Planning Board and Ordinance Committee revised the Shoreland Zoning Ordinance and held two public hearings. The Planning Board is waiting to see what action, if any, the State takes on Shoreland Zoning regulations before proceeding with finalizing the DRAFT for the Shoreland Zoning Ordinance.

The CEO has issued Plumbing Permits and Permits in the Shoreland Zone under his jurisdiction.

The Planning Board discussed possible uses for Liberty Hall and appointed Rick Bury as Liaison between the Planning Board and the Liberty Hall Committee.

The Planning Board has recently recommended to the Board of Selectmen that the Town appoint a committee and set aside funding for the Sestercentennial celebration – the 250th year of Incorporation of the Town of Machiasport in 2013.

The Planning Board meetings are held on the 2nd Thursday of each month at 7:00 p.m. and the Ordinance Committee meets at 6:00 p.m. on the same day at the Town Office.

All Planning Board and Ordinance Committee meetings are posted 7 days in advance of the meetings on the Town's Bulletin Board and are open to the public. Copies of the agendas for the upcoming meetings and minutes from the previous meetings are also posted in the Town Office at that time.

Building Permits are due in the Town Office the Friday prior to the week of the Planning Board meeting and all permit fees must be paid at that time.

We want to thank the Community and Selectmen for their ongoing support.

WARRANT
2012 ANNUAL TOWN MEETING
TOWN OF MACHIASPORT, MAINE

To: Jonathan Rolfe, a Constable in the Town of Machiasport, County of Washington, and State of Maine.

GREETINGS:

In the name of the State of Maine, you are hereby required to warn and notify the inhabitants of the Town of Machiasport, in the County of Washington, and the State of Maine, qualified by law to vote in Town affairs, to meet at the Municipal Complex, in said Town, on Tuesday the 12th day of June, 2012, then and there to act on Article 1 and by secret ballot on Article 2 as set out below, the polling hours therefore to be from eight o'clock in the forenoon until eight o'clock in the evening;

And, to notify and warn said inhabitants to meet at the Fort O'Brien School in said town on Monday, the 25th day of June, 2012 A.D., at six o'clock in the evening, then and there to act on Articles 3 through 43.

ARTICLE 1: To elect a moderator to preside at said meeting.

ARTICLE 2: To elect all municipal officers and school committee members as are required to be elected.

ARTICLES 3 -16 FOR TOWN OF MACHIASPORT
SCHOOL BUDGET

ARTICLE 3: Shall the Town be authorized to expend \$654,738.78 for Regular Instruction?

ARTICLE 4: Shall the Town be authorized to expend \$179,790.76 for Special Education?

ARTICLE 5: Shall the Town be authorized to expend \$9,455.27 for Other Instruction?

ARTICLE 6: Shall the Town be authorized to expend \$500.00 for Student and Staff Support?

ARTICLE 7: Shall the Town be authorized to expend \$47,749.99 for System Administration?

ARTICLE 8: Shall the Town be authorized to expend \$30,914.59 for School Administration?

ARTICLE 9: Shall the Town be authorized to expend \$45,733.52 for Transportation and Buses?

ARTICLE 10: Shall the Town be authorized to expend \$160,439.46 for Facilities Maintenance?

ARTICLE 11: Shall the Town be authorized to expend \$64,203.33 for All Other Expenditures?

ARTICLES 12 THROUGH 13 RAISE FUNDS FOR THE

PROPOSED SCHOOL BUDGET

ARTICLE 12: Shall the Town appropriate \$879,158.18 for the total cost of funding public education from kindergarten to grade 12 as described in the Essential Programs and Services Funding Act and shall the Town raise \$766,770.59 as the Town's contribution to the total cost of funding public education from kindergarten to grade 12 as described in the Essential Programs and Services Funding Act in accordance with the Maine Revised Statutes, Title 20-A, section 15688?

Explanation: The Town's contribution to the total cost of funding public education from kindergarten to grade 12 as described in the Essential Programs and Services Funding Act is the amount of money determined by state law to be the minimum amount that a municipality must raise in order to receive the full amount of state dollars.

ARTICLE 13: (Written ballot required) Shall the Town raise and appropriate \$275,585.40 in additional local funds, which exceeds the State's Essential Programs and Services allocation model by \$256,381.66 as required to fund the budget recommended by the school committee?

The school committee **recommends \$275,585.40** for additional local funds and gives the following reasons for exceeding the State's Essential Programs and Services funding model by \$256,381.66: The Machiasport School Department budget is over the Essential Programs and Services model in student to teacher ratios in the elementary school, school administration, guidance, library, system administration, maintenance, clerical costs, and the difference between the secondary tuition rate and the EPS tuition rate. In addition, the Essential Programs and Services model does not fully fund co-curricular activities and the model has not been fully funded by the State.

Explanation: The additional local funds are those locally raised funds over and above the Town's local contribution to the total cost of funding public education from kindergarten to grade 12 as described in the Essential Programs and Services Funding Act that will help achieve the Town budget for educational programs.

ARTICLE 14 SUMMARIZES THE PROPOSED SCHOOL BUDGET

ARTICLE 14: Shall the Town authorize the school committee to expend \$1,193,525.70 for the fiscal year beginning July 1, 2012 and ending June 30, 2013 from the Town's contribution to the total cost of funding public education from kindergarten to grade 12 as described in the Essential Programs and Services Funding Act, non-state-funded school construction projects, additional local funds for school purposes under the Maine Revised Statutes, Title 20-A, section 15690, unexpended balances, tuition receipts, state subsidy and other receipts for the support of schools?

ARTICLE 15 AUTHORIZES EXPENDITURES OF GRANTS AND OTHER RECEIPTS

ARTICLE 15: Shall the Town be authorized to expend such other sums as may be received from federal or state grants or programs or other sources during the fiscal year for school

purposes provided that such grants, programs or other sources do not require the expenditure of other funds not previously appropriated?
